Parks Alliance

In June 2013 a new national alliance of dozens of key national green space organisations was formed to stand up for the interests of the UK's green spaces. In this it will build on the good work of the Greenlink coordination meetings, which have now ceased due to the demise of the charity Geenspace. Details of a follow up PA meeting in the autumn will be announced soon.

Horticulture Week reports: Plans to build an alliance to tackle the funding crisis facing public parks took a significant step forward at the beginning of the summer as a cross-sector group of parks and allied representatives gathered in London to agree the next steps for the initiative including the creation of a transitional board. Nearly 40 key sector executives from across the UK discussed the way forward at the second Parks Leadership Round Table, hosted by Horticulture Week.

Prompted by Horticulture Week's 'Make Parks a Priority' campaign, the round table was formed to provide a shared industry voice amid Government and council cuts as well as a stumbling economy. The group agreed a strategy document for the Parks Alliance prepared by one of the working groups that states the alliance's core mission is "to provide campaigning leadership and put public parks at the heart of the drive for healthy, resilient and sustainable communities" to be achieved through "a broad range of leadership programmes, actions and plans". Participants agreed to set up a transitional board that will meet before the next round table event.

Facilitator Professor Chris Baines said it was fantastic to see so many people "committing to this process". He added: "We are on the brink of a complete step change in the status of parks and the seriousness with which they are taken by governments." He called for "the magic missing ingredient" to help "common sense reach the people who make decisions".

The Parks Alliance goals:

- Be a single unified voice for the UK's green-space organisations and stakeholders.
- Become the missing champion of public parks across the UK.
- Make the case for parks, seek protection, investment and sustainable funding.
- Seek the endorsement of national and devolved UK governments.
- Seek to involve, inspire and inform.
- Seek to influence the future direction of the green-space sector.
- Press for investment in training and support innovation and skills.
- Promote environmental sustainability.
- Use the word "parks" to mean all public green infrastructure.
- Promote the Green Flag standard as the benchmark for parks.

Green Infrastructure Partnership updates

NEW ECONOMIC EVIDENCE REPORT: Investment in multi-functional green space or Green Infrastructure (GI) encourages inward investment and can attract increased visitor spending at a local level, according to findings of a new research study published 15/08/2013. GI can also benefit national economic growth by helping reduce flood risk, improve air quality and provide health benefits. This in turn boosts productivity, the study, Green Infrastructures contribution to economic growth: a review found.

The EFTEC (Economics for The Environment Consultancy Ltd) and Sheffield Hallam University report, which reviewed current national and international studies examining the link between green infrastructure and economic growth, found qualitative and quantitative evidence to show six ways in which green infrastructure acts as a catalyst to growth. Scottish Household Survey 2012 - greenspace results

News from Greenspace Scotland... The latest Scottish Household Survey (SHS) annual report was published on 28th August 2013. The 2012 survey included questions on access to greenspace. Key findings include:

Access to greenspace

Over two thirds (71%) of adults in Scotland have access to a useable local greenspace that is within a six minute walk from their home. Access to local greenspace differs by area deprivation levels. More than half (61%) of those living in the 20% most deprived areas of Scotland have access to useable greenspace within a six minute walk, rising to a high of 75% of those in the top three least deprived areas. Those in the most deprived areas are twice as likely as those in the least deprived areas to say that a local greenspace area that they and their family can use is more than a 14 minute walk away (19% versus 9%). There is also an association between access to greenspace and how people rate their neighbourhood as a place to live. Three quarters (75%) of adults who rate their neighbourhood as a very good place to live say they have access to useable greenspace within a six minute walk, compared to just under two thirds (60%) of those rating their neighbourhood as very poor.

Use of greenspace

Overall less than a third (28%) of adults use their local greenspace either every day or several times a week, which is lower than those who use them less often (40% in total) or not at all (32%). There is a strong link between how far people have to walk to reach their local greenspace and how often they use it. Adults who live less than a 6 minute walk from useable greenspace are more than twice as likely to

use it every day or several times a week than those who live a 7-13 minute walk away (35% versus 14%), and are nearly four times more likely to use it every day or several times a week than those who live more than a 14 minute walk away (35% versus 9%). Frequency of use of local greenspace differs considerably by area deprivation levels. A fifth (21%) of those in the 20% most deprived areas of Scotland use their local greenspace every day or several times a week, compared to under a third (29%) of people in the 20% least deprived areas.

Greenspace and health

Those adults who have useable greenspace within a six minute walk from their home are more likely to say their health in general has been very good or good than those whose nearest useable greenspace is more than a fourteen minute walk away (75% versus 69%). Similarly those whose nearest useable greenspace is more than a fourteen minute walk away are more likely than those for whom it is less than six minutes away to say that they their health is bad or very bad (9% versus 6%). Those who use their local greenspace every day or several times a week are much more likely to say that their health in general is good or very good than those who don't use it at all (80% versus 65%). Similarly those who never use their local greenspace are almost three times as likely as those who use it every day or several times a week to say their health is bad or very bad (11% versus 4%).

Satisfaction with greenspace

Nearly three quarters (73%) of adults in Scotland are satisfied with their local greenspace, with only 9% being dissatisfied. Across all age groups 7 in 10 people are satisfied with their local greenspace, with the highest levels of dissatisfaction, compared to the population as a whole, being reported by the 35-44 age group (12%).

There is considerable variation in satisfaction with greenspaces by area deprivation levels. Just under two thirds (61%) of those in the 20% most deprived areas are satisfied with their local greenspace, rising to over three quarters (81%) of people in the 20% least deprived areas.
