DM intends to phone around potential new trustees – specifically reps from established, active Forums in key regions to encourage wider NFPGS trustee representation to include these areas. This could include Yorkshire/ NE England, Scotland and Wales.

NFPGS Update	
Pre-election campaigning	
Following comment at the previous meeting re. the likely forthcoming general election, DM	DM

noted that there is a statement and campaign to support London groups which could provide the basis for pre-election campaigns in other areas. DM to share details for further discussion.

DM added that the 'A More Natural Capital' coalition will include a focus on green spaces at hustings leading up to the London mayoral elections in May.

NFPGS initiatives, projects, campaigning

Research

PE updated. UCL has included green space research options on a student noticeboard with a view to involving local students in work which could have possible wider application, potentially enabling other Area Forums to replicate with a local university (e.g. Sheffield, Leeds, etc.). SR added that BOSF has links with a student currently researching 'The Right to Grow'.

DM – many London Network meetings involve specific working groups (eg biodiversity, climate resilience, dogs, commercial events) which could link with research themes.

BOSF is working with the RHS (also Liverpool, Cardiff and Manchester contacts) on a pilot prison service growing project - preparing plug plants from seed to enable community groups to grow produce for food banks.

PE added that research questions being considered by Sheffield include:

- how active are community groups in green space decisions?
- Does the role/ activity vary according to level of deprivation?
- Does the quality of sites improve if groups are involved in the decision process?

Sector events

DM/PE attended a meeting to review the Nature Based Inclusion Survey. 30 groups had responded. Final results and a report to follow.

DM/PE

The session included reps from Natural England who are involved in discussion with Groundwork and the National Trust about 'green community hubs', as a focus for engagement in the natural world. 10 pilot projects are due to report – DM is due to attend discussion in March and intends to lobby for the role of parks to be more recognized. DM to share information once available.

PE has also been involved in National Nature Recovery and Biodiversity Net Gain work which has also highlighted the role of communities, but PE felt there is greater potential Friends group input.

SQ-H and NS are due to attend an APSE biodiversity seminar in Manchester, 14 March, after DM procured two free places.

Finance/ administration

SQ-H confirmed the final total from the crowdfunder campaign was £2,608.35.

PE is working through work priorities but then will focus on the reviewing and revising a draft

bid to the National Lottery Heritage Fund.	
There has been no further comment following the discussion with The Lund Trust, hopefully the new financial year may yield positive comment.	
Other admin. priorities remain the need to confirm authorized signatories — DM has resubmitted personal details and bank approval should be confirmed. NS also needs to progress similar. An invoice for GreenNet services remains outstanding for immediate payment.	
Future meetings Following previous discussion, there is a need to advance the date of the next AGM to move towards synchronizing future meetings with NFPGS annual reporting. With this in mind, a provisional date for the next AGM will be Saturday 16 th November.	
It was agreed that a further general meeting to sustain momentum and communication could be held in early summer: provisionally 7.30-9.00pm, Wednesday 12 June.
